- The Committee noted the increasing use of liability management exercises in the European market. It also noted ongoing challenges to certain of these in various jurisdictions.
- The Committee noted the rise in cases in relation to s. 423 of the Insolvency Act.

4. The Committee noted the publication of the Practice Statement from the Chancellor of the High Court: Part 26 of the Companies Act 2006

The Practice Statement will apply in all cases where an application for a meetings order is to be dealt with at a convening hearing listed on any date on or after 1 January 2026.

The Committee further noted that at its January meeting it would be helpful to get feedback from committee members on their experience of obtaining court hearing dates for restructuring plan and scheme hearings in light of the change in process pursuant to the new Practice Statement.

5. Legislation

The Committee noted Carbon Dioxide Transport and Storage (Licensed Operators) Administration (England and Wales) Rules 2025 published on 23rd October 2025, laid before Parliament on 29th October 2025, and coming into force on 19th November 2025.

The Committee further noted that Part 9 of Schedule 18 to the Energy Act 2023 sets out that regulations may provide for the introduction of a special administration scheme for heat network operators, similar to that which operates for gas transporters and electricity transmission and distribution network operators. This special administration regime is not yet in force.
