- 5. Insurance/Professional Negligence Sub-Group
 - a. Successful event shared about on 27 February well received.
 - b. Friendly panel disagreement added to the discussions.
 - c. Have already hosted two events, can brainstorm new ideas. Host this meeting before the May AI Committee meeting.
- 6. UK IP Consultation and AI Regulatory Sub-Group
 - a. As agreed during the last meeting, Zofia took forward liaising with the CLLS IP Committee on a joint response to the UK IPO's consultation.
 - b. Per the discussion during our last committee meeting, the CLLS IP Committee had concerns that a blow-by-blow response to all of the items that the UK IPO was consulting on was not appropriate (including because of the differing interests of CLLS member law firms' clients and because a number of the decisions to be made are 'political' decisions).
 - c. Instead, the CLLS IP Committee proposed a high-level response offering some guidance on issues to consider as part of the government's choice of any particular option.
 - d. Zofia fed three points into the response for the government to consider:
 - i. That, if the government were to implement a text and data mining exception with the right for rightsholder to opt out of their works being used in that way, it may want to consider certain technical standards for machine reasonable opt-outs to avoid the same uncertainty that exists in the EU as to what constitutes a valid opt-out.
 - ii. Whether requirements to label outputs generated by AI might result in uncertainty of provenance if a material proportion of AI outputs are not correctly labelled on a consistent basis, whether due to technical or operational reasons or a lack of / dishonest implementation by AI systems and contribute to mis- and disinformation (by releasing AI outputs without a label, or by adding labels to non-AI generated material)
 - iii. The increased importance of AI assurance techniques if a policy of encouraging use of synthetic data to train models to be pursued.
 - e. CLLS IP Committee contributed two items, one relating to the government's proposal for collective licensing regimes in this context. The response was then submitted from both committees, signed by the chair of the IP committee, and it is available on the CLLS website: CLLS response to UKIPO Consultation 25 February 2025.
 - f. Thanks to Zofia and others for engaging with IP Committee and sharing output.
